Latest Developments

The family of two Palestinian brothers—Mahmoud Fuad Atiyeh, born in 1992, and Ali Fuad Atiyeh, born in 1990, has appealed to the local and international human rights institutions to work on disclosing the fate of their missing sons.

The two brothers, both residents of Yarmouk Camp, in Damascus, disappeared on July 8, 2018. Their condition and whereabouts remain unknown.

Unverified reports have emerged that the two brothers are secretly held at Syria's state-run Adra jail.



In another development, fires broke out on Sunday at a bakery in AlNeirab Camp for Palestinian refugees, in Aleppo.

The incident was attributed to a technical error in fuel-transfer to the furnace. Heavy material damage was reported.

On May 24, 2019, at least seven persons were left injured in AlNeirab Camp in fires rocking a fuel store.

In the meantime, residents of Khan Dannun Camp for Palestinian refugees, in Rif Dimashq, continue to set off alarm bells over a sanitation crisis imperiling their life and that of their children in the area.

The displaced families warned of the life-threatening diseases wrought by poisonous rodents and unpleasant smells stemming from contaminated sewage.

Pictures circulated on social media show floods of waste water swamping Khan Dannun's residential alleyways and thoroughfares.

The families called on the concerned authorities and relief institutions, namely UNRWA, to make urgent steps in order to rinse out waste water and enhance hygiene in the area.

The residents lashed out at the local authorities for turning blind eyes to their appeals to enhance infrastructure and basic services.

Living conditions in Khan Dannun have sharply deteriorated due to the lack of financial resources and high unemployment rates wrought by the raging warfare. A transportation crisis has added bad to worse.

Upon more than once occasion, civilians have railed against the mounds of trash and debris piled up in civilian neighborhoods and around the main access roads to the camp, resulting in bad smells and the spread of life-threatening diseases and rodents.

Meanwhile, Turkish coast guards detained 35 irregular migrants, among them a number of Palestinian refugees, who were trying to reach Greek islands, after they set sail from Evros River, between Turkey and Greece.

Turkish news outlets said the migrants were transferred to a detention center in Edirne, pending the finalization of legal procedures in this regard.

In another development, The Follow-Up Committee in Lebanon's western and central AlBekaa region, in partnership with Atfal AlSoumoud Association and Friends of Palestine—Japan, distributed, on June 2, 860 food baskets to displaced Palestinian families from Syria.
