Victims

Palestinian refugee Aws Abed Haidar, born in 1987 and nicknamed Abu Ishaq, died as he fought alongside ISIS against the Syrian government forces in Teloul AlSafa, in AlSweida desert, south of Syria.

Aws left Yarmouk Camp following a deal struck with ISIS and the Syrian government forces stipulating that ISIS gunmen in southern Damascus retreat to AlSweida desert, south of Syria.



Latest Developments

The Turkish authorities released the Palestinian refugee Zakiya Mustafa Amer, formerly sheltered in Handarat Camp in Syria, after she had been detained for 13 days at the Central Prison in Antakya, south of Turkey, over allegations of creeping into the Turkish-Syrian borders.

An AGPS reporter said Zakiya's release was brokered by Palestinian institutions and NGOs.

Zakiya received a kimlik card allowing her to freely move across Turkey.

Scores of Palestinians from Syria continue to attempt to enter Turkey via illegal routes after the country has tightened grip on its borders with Syria.



At the same time, an AGPS reporter said Syrian opposition outfits and Turkish troops moved into AlMuhamadiya Camp, in Deir Ballout, north of Syria, on Wednesday morning to knock down makeshift structures set up by the displaced families around their tents so as to protect their children during winter.

The residents expressed their deep disappointment over the measure, which they said has come at a time when civilians have been grappling with dire conditions in the area.

A delegation of Deir Ballout committee reached out to the opposition outfits and Turkish authorities in order to urge them to backtrack on the move and refrain from demolishing the dams set up by the residents to protect their children against water floods expected to swap their tents with the advent of winter.

However, both parties reportedly told the delegation that the demolition will also target barriers built around Deir Ballout Camp.

The displaced Palestinian and Syrian families appealed to the Turkish authorities and human rights organizations to take urgent measures in order to protect their children from rain floods and freezing temperatures and to supply them with much needed heating kit, fuel, and foodstuff.

Families who have been forcibly deported to northern Syria have been enduring abject living conditions and crammed into poorly-equipped tents.

In the meantime, the committee overseeing debris clearance in Yarmouk said efforts have been ongoing to remove rubble from the vicinities of AlKhames Clinic, UNRWA schools, Yarmouk Girls' High School, and AlMalikiya School.

Debris clearance has also been in progress in AlMaghareba neighborhood and Street 15. A number of access roads have been re-opened in the area.

A UNRWA delegation and representatives of the General Authority for Refugees are expected to pop in the area on Saturday morning to inspect the damage wrought on UNRWA schools and facilities and

set up a reconstruction plan, pending the final consent of the Syrian government.

Meanwhile, Palestinian refugee Mansour Mahmoud Falah, born in 1950, has been locked up in Syrian government dungeons for the fourth year running.

He was kidnapped by pro-government groups at a checkpoint pitched in Khirbet AlWard, in Rif Dimashq, on May 26, 2014.

AGPS documented the incarceration of over 1,696 Palestinians in Syrian government penitentiaries, where scores of refugees have also been tortured to death.
