Latest Developments

Palestinian refugee Mustafa Mahmoud AlNaser, called Abu Bakr AlHalabi, continues to appeal for information over the condition and whereabouts of his wife Israa AlHariri, with whom he has lost contact since May 2018, when thousands were deported from Yarmouk Camp and southern Damascus to northern Syria.

AlNasser said that his wife and himself left the area in separate batches, before they lost contact. He said he searched for her in Deir Ballout Camp, in Afrin outskirts, where he was told that she headed for the I'zaz refugee camp and that she was holding a seven-month toddler in her arms.



Over 9,000 persons were deported to Daraa AlFurat region, taking shelter in such refugee camps as Deir Ballout, Shbeiran, and I'zaz, along with other camps in AlBab and Idlib cities, among other areas.

In another development, UNRWA's Director of Programs, Syria Field Office, Amany Michael Ebye, and member of the Fatah Central Committee, Samir AlRefa'i discussed the situation of Palestinian refugees in war-torn Syrian and the vital role paid by

the UN refugee agency to assuage the calamitous condition endured in Yarmouk Camp, among other Palestinian refugee camps.

In a meeting held a couple of day earlier, both sides discussed UNRWA's projected measures to reconstruct its destroyed premises in Yarmouk Camp and rehabilitate educational facilities.



AlRefai briefed the UNRWA official about the steps made by Fatah Movement to boost support for the UN agency and garner further funds so as to reconstruct Yarmouk's ruined infrastructure and facilities, most notably UNRWA schools, clinics, and a Youth Development Center, along with relief offices and aid distribution centers.

Meanwhile, 10 members of a Palestinian refugee family have been held in Syrian government jails since June 16, 2013.

AGPS identified the family members as: Mahira Mahmoud Amayri (born in 1964), Hadeel Mahmoud Amayri (born in 1987), Aseel Mahmoud Amayri (born in 1988), Widad Mahmoud Amayri (born in 1990), Razan Mahmoud Amayri (born in 2000), Suheer Mahmoud Amayri (born in 1981), and Maysaa Jamal Idris (born in 1979).

The list also includes Firas Waleed Dasouki (born in 1978) and his children Hamza Firas Dasouki (born in 2011) and Hala Firas Dasouki (born in 2012).

The family members were all kidnapped by the Syrian army squads at a checkpoint in Nisreen Street, in ALTadhamun neighborhood.

AGPS kept record of the incarceration of 1,730 Palestinian refugees in Syrian state dungeons, among them 108 women and girls.

In the meantime, Palestinian refugee from Syria Fidaa Suleiman earned the gold medal in Austria's 2019 Kickboxing Championship, in the second such medal won at the competition. A few days earlier, Palestinian refugee from Syria Hamza AlKurdi, aged 24, received a gold medal.

The team, led by Palestinian coach from Syria Muhammad Suleiman, earned 11 medals in the contest.

Fidaa is one among thousands of other Palestinian refugees who fled war-ragged Syria to European countries as they rummaged around for safer shelters and promising careers.
