## Victims

The Free Palestine Movement, one of the Palestinian military groups affiliated to the Syrian regime, announced the death of its Palestinian fighter “Shady Abd Al-Hafez Ahmed Mawed,” after clashes that broke out the day before yesterday, between the Syrian regime and the Free Palestine Movement, and ISIS, in Yarmouk camp, south of Syria. He was a resident of Yarmouk camp.

AGPS has documented 996 deaths of Palestinian refugees, who have died due to gunshot wounds amid the war in Syria.



## Latest Developments

AGPS’s documented statistics reveal that the number of Palestinian refugees who have died because of the ongoing war in Syria, has reached 3615 victims since 2012.

The statistics show that 1148 refugees died because of the exchanged bombardments between the Syrian regime forces and the armed Syrian opposition groups.

While the clashes between the regime and the opposition led to the death of 946 refugees, in addition to 475 men and women who have

died due to torture during their interrogation in the Syrian regime prisons.

307 Palestinians died of sniper shots, and the siege of the Palestinian refugee camps by the Syrian regime and a number of the Palestinian factions affiliated to it, has led to the loss of 201 lives because of malnutrition and the lack of medical services, resulting from the siege.

The remaining deaths were due to several different reasons including explosions, civilian executions and drowning while attempting to reach Europe.

It is noteworthy that AGPS documents all the Palestinian refugee victims, despite their political position or the body responsible for their death.

In the meantime, activists quoted local sources in south Damascus, saying that two members of ISIS left the area of Al-Hajar Al-Aswad, in coordination with the regime.

They are “Abu Sohaib Al-Khabory,” brother of “Abu Hesham Al-Khabory” who is the former leader of ISIS in Al-Hajar Al-Aswad, and “Abu Zahraa,” in addition to Al-Khabory’s brother who is not a member of ISIS, according to the sources.

Our reporter added that the members left from the southern area through the Bardy checkpoint, which belongs to the Syrian regime, to an unknown destination.

Leaders of ISIS and those close to them are continuously leaving the area, amid talks about finding a close solution that will end ISIS's control over Al-Hajar Al-Aswad and Yarmouk camp. Regarding the members who will remain to face their fate after all the leaders leave the area, their situation has not yet been concluded.

Many leaders and members of ISIS left the areas controlled by the organization in the past period of time, the latest being Rateb Tayara, the former media representative of ISIS, leaving from the Martyrs Sector in Yarmouk camp.

Violent clashes occurred yesterday, using medium weapons and guided bombs, between ISIS and Jaish Al-Islam at the Zein neighborhood axis in the south of Yarmouk camp. The clashes lasted several hours decreasing its intensity with the sunset. No injuries have been heard of on both sides.

### **Local Work Committees**

The Charitable Association for Palestinian relief, along with the Palestinian Red Crescent, ended its medical week event in the Khan Al-Sheih camp for Palestinian refugees, in the suburbs of Damascus.

According to the Association, 261 people benefited from the week, where free medical check-ups and medication were given to the patients, in various medical specialties.



### **Palestinians of Syria: December 01, 2017 Statistics:**

- The total number of victims documented by the Action Group is 3615, including 463 women
- 1643 Palestinians are locked up behind Syrian government's bars, 105 of which are women
- Yarmouk refugee camp is under the Syrian regime army and Popular Front for the Liberation of Palestine's siege for 1,598 days in a row
- 204 refugees, mainly in Yarmouk Camp, have died due to lack of medical care and malnutrition
- Water supplies have been cut off Deraa Camp for 1335 days, and 1175 days in Yarmouk Camp
- Residents of Handarat Camp, in Aleppo have been banned from their homes for 1,671 days. Government troops have taken over the camp for more than 434 days.

- Approximately 85 thousand Palestinian-Syrian refugees fled to Europe by the end of 2016
- 31 thousand refugees are located in Lebanon
- 17 thousand refugees are sheltered in Jordan
- 6 thousand refugees are in Egypt
- 8 thousand refugees are staying in Turkey
- One thousand refugees are present in Gaza
