Recent Updates

The Syrian Regime forces targeted the houses at the eastern part of Khan Al Shieh Camp in Damascus Suburb with the Antiaircraft GunZSU; Where Ibrahim Soud's house was targeted and didn't result in any casualties.

The eastern lane of Khan Al Shieh camp was targeted the day before with a number of mortar shells that led to material damages. The surrounding areas of Khan Al Shieh were targeted in a random bombing with explosive barrels and mortar shells and the continuation of clashes between the Regular Army and the Opposition Armed Groups.



In the middle of Syria, AGPS correspondent in Al Aedin camp in Homs reported that the Syrian Security raided some people's houses two days ago, as he clarified that the security members raided the houses and the shops of Al Hajj Yahiya Palestinian family at Al Aedin camp in Homs to search for the Palestinian refugee Moutaz Al Hajj Yahiya abu Eyad who is in his fifties, according to the Syrian Security while raiding the house.

The raid didn't lead to arrest him because he escaped out of Syria. Al Aedin camp in Homs, which is governed by the Regular Army, lives under



unprecedented security measures, where its residents feel like they live in a big prison.

The Syrian Security built iron walls that separate the neighborhoods of Al Aedin camp in Homs and its surrounding areas without any crossings between the two sides which increased their economic burdens and was negatively reflected on their living situation.

In the same context, The continuation to close the only road that connect Aleppo with Al Nairab camp affected the residents' lives who live in the camp and suffering from the loss of some of food, medical, and basic materials such as medicine.

The AGPS correspondent insured that the market of Al Nairab camp witnessed a high rise of material prices which increased the burdens of the Palestinian refugees in Aleppo and Al Nairab camp, especially the fuel which its demand was increased due to cold.

The areas surrounding the camp still witness violent confrontations between the Regular Army alongside its groups against the Opposition Armed Forces at Khanaser and Athreya area.

In North Syria, the operation room of the Opposition armed groups at Yelda distributed statement to the residents of Yarmouk camp, that determined the time to enter and exit the camp to Yelda and that the crossing will be open from 7 am till 5 pm.

The Opposition noted that anyone moves out





of this time will be a target and it is not responsible for the live of any person out of this time. It is mentioned that Yelda area is considered the only exit for the entry of the food aid to the besieged residents of Yarmouk camp.

The opposition closed the road for many times because it accused ISIS and Nusra Front at Yarmouk camp and AlHajar Al Aswad of assassinating many of its members and a number of activists at Yelda.

In a different context, the displaced residents of Yarmouk in the surrounding areas suffer from difficult humanitarian situations due to ISIS control over Yarmouk camp on April 2015.

A video report, was prepared by Fajer Press, shows the miserable living situation of 2000 Palestinian families in the shelters at Yelda, Babila, and Bait Sahn where the centers lack the minimum live essentials.

The displaced residents of Yarmouk camp complain from the negligence of the concerned parties in the Palestine affairs specially PLO, Palestinian factions, and UNRWA, they also complain the absence of relief and medical services, in addition to the heat means for them and their children.

The video Report clarified that some relief organizations such as Palestine Charity Commission, Jafra, and Themar Charity are still providing services to the displaced Palestinian refugees in these areas.

They provide the basic needs such as food, medicine, and water to alleviate the suffering of siege and displacement despite the lack of materials resources. The Palestine Charity Commission distributed



school bags and stationeries to the students of Yarmouk camp at the surrounding areas such as Yelda, Bait Sahn, and Bebla.

The Medical Department in the Palestine Charity commission still provide free medicine to the Displaced Yarmouk residents in the surrounding areas and inside the camp, where the distributed about 1640 free medicine prescriptions including 250 prescriptions to Typhoid disease.

It is referred that Palestine Charity Commission continues to provide its serviced to the Residents of Yarmouk Camp despite the closure of its offices inside the besieged camp.



Statistics

The AGPS documentation and monitoring team documented the death of 26 victims who died during October 2015, while 37 refugees died in October 2014 due to the ongoing conflict in Syria.

The AGPS noted that the 37 victims who died in October 2014 included 6 refugees died due to torture in the regime's prisons, 17 refugees died due to a gun shot, 7 refugees died in a car explosion, 4 refugees died due to



shelling, 2 refugees died due to a sniper shot, while Adel Deyab drowned while trying to cross between Turkey and Greece in order to migrate to the European countries.

Numbers and Statistics till 2/11/2015

- *15,500 Palestinian Syrian refugees in Jordan, 45,000 Palestinian Syrian refugees in Lebanon, and 6,000 refugees in Egypt, according to the UNRWA's statistics till July 2015.*
- *At least 36,000 Palestinian Syrian refugees have reached Europe during the last 4 years.*
- *The Yarmouk Camp: - Siege, imposed by the Regular Army and PFGC, continued for 854 days respectively. In addition, power cuts continued for more than 924 days, water was cut for 414 days respectively. The number of victims due to the siege has reached to 182 victims.*
- *Al Sbeina Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 715 days respectively.*
- *Handarat Camp: - Residents have left the camp for 916 days after the Syrian Opposition Groups controlled it.*
- *Dara'a Camp: - It is now almost 560 days without water and 70% of its buildings were demolished.*
- *Jarmana, AL Saieda Zainab, Al Raml, Al Aedein Camps in Homs and Hamma: - A relatively quiet situation in light of the economic crises.*
- *Khan Al Sheih Camp: - Roads linking the camp to the city center are still closed except for Zakia- Khan Al Shieh road.*
