



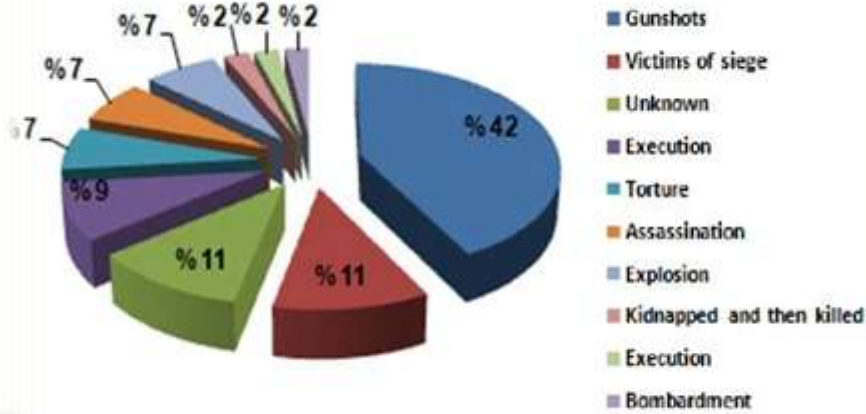

Statistics

The AGPS documentation and monitoring team declared that 45 Palestinian refugees died during February 2015 including 19 refugees due to fire shooting, a refugee due to bombing and clashes, 3 refugees died due to torture in the Syrian Regime prisons, 5 died due to siege and the lack of medical care, 5 victims died due to unknown reasons, 5 refugees were executed in the field, 3 were assassinated and 3 refugees died due to explosions.

The AGPS referred that the Palestinian victims who died in February were distributed according to cities as follows:- Damascus 11 refugees, Damascus Suburb 11 refugees, Dar'aa 7 refugees, Aleppo 3 refugees, 7 refugees died in separate border areas, 4 victims in Homs and two victims in Hama.

Victims

The AGPS received news that the Palestinian refugee Ahmed Kheir Mohammed Talal died in Syria, he was born 1991 and from Khan Al Sheih camp, Where the AGPS was not able to make sure of the news from another source.

The old man Ahmed Khalid Derbas who was born in 1955 died due to drought, malnutrition and the lack of medical care which raises the siege victims' toll to 172 victims.

Recent Updates

The residents of the Yarmouk camp for Palestinian refugees in southern of Damascus returned to stand in long queues in order to get a little amount of soup and spices due to the stop of UNRWA aids distribution for more than two months and a half respectively and the continuation of the siege that is imposed on the Yarmouk camp since 604 days respectively.

In light of the absence of the required role of the international and official organizations such as UNRWA and the Public Commission of the Palestinian Refugees due to the prevention of the Syrian regime to enter the aids to the camp, a number of charity, civil and relief organizations and independent committees though their lack of potentials they provided the camp with the social and humanitarian services such as health and education to the remaining Palestinian refugees inside the camp.

The Palestine Charity Commission, the Commission of the Palestinian People Relief, Jafra organization for Relief and Development and other committees inside the camp distributed a number of food packages and food vouchers after they bought them from the crises merchants with double prices and they held teaching sessions in the mosques and houses and they also secured drinking water for the residents of the camp.

The commissions and organizations have conducted the activities that the Yarmouk Municipality Local Committee should do such as managing the public facilities inside the camp. The Municipality Committee stopped working anything in the camp including health and services which led to



pile up the garbage, the medical waste and the damage rebels in the streets and lanes of the camp that bodes of a big humanitarian and environmental catastrophe. This prompted the volunteers from the residents of the camp to do this task and to perform cleaning campaigns titled as “Roll up Your Sleeves and Clean” that was done by the Charity Commission for the Relief of the Palestinian People. On the other hand, the water cut on the houses of the Yarmouk camp since 147 days respectively, the power cut and shortage of basic services led to the appearance of diseases due to water cut such as kidney and pancreas or diseases due to uncleanness such as skin diseases.

In Aleppo, Many youth from Al Nairab camp were forced to leave their camp to Turkey due to the security tension that is spread in their area. It is referred that Al Nairab camp is considered a strategic area in Aleppo because it is close to Al Nairab Military Airport which serves the Syrian Regular Army.

Jaramana camp residents in Damascus Suburb are suffering of severe living crises manifested in the high prices, the lack of food materials and poverty. It is mentioned that most people stopped working specially the free work people who form a big number in the camp due to the ongoing conflict in Syria.



Civil Work Committees

The Service Department of the Palestine Charity Commission continues with the campaign of cleaning the streets of the Yarmouk camp from the garbage and the buildings rebels. The campaign came as intensive efforts for the relief organizations inside the camp to get the trash far from the houses of people in order to stop the spread of the diseases. The Palestine Charity also distributes water on the houses of the besieged Yarmouk camp in order to alleviate their suffering.

Lebanon

The Palestinians of Syria Workers League in cooperation with Palestinians of Syria committee in Lebanon in support and sponsorship of the Help Community organization in Germany in implementing the project of lighting the houses of the Palestinian refugees coming from Syria to Lebanon at Al Qarya Al Seheyya in Al Beqaa Al Awsat. The project comes as to alleviate the suffering of the refugees' families and to minimize the consequences of the power cut problem. It is mentioned that the number of the Palestinian Syrian refugees in Al Beqa' area is 7420 refugees from 53000 Palestinian refugees who resorted to Lebanon escaping from the ongoing war in Syria.

Netherland

Within the European week for solidarity with the Palestinians of Syria and within the activities and workshops that were held in the European Union countries, Al Quds Cultural Center in Rotterdam in support of the Palestinians of Europe Conference, Palestine Return Center and the Palestine House in Netherland hosted a workshop to discuss the situation of the Palestinian refugees coming from Syria to Europe. The workshop included several Palestinian personalities from Netherland, Britain, Germany, Sweden and France.

The participants of the workshop discussed two topics the first is the situation of the new incoming Palestinians of Syria refugees to European Union countries and the challenges and difficulties that they faced in



their road and finding solutions to let them adapt with the new situation. The second topic, they discussed the Palestinians of Syria situations and their suffering inside the Palestinian camps in Syria specially the unfair siege that is imposed on the Yarmouk camp. The workshop was concluded with a statement that contains decision, results and recommendations which will be announced in hours.



Numbers and Statistics till 02/3/2015

- *At least 27933 Palestinian Syrian refugees have reached Europe during the last 4 years.*
- *2679 Palestinian Victims were documented by the AGPS*
- *The Yarmouk Camp: - Siege, imposed by the Regular Army and PFGC, continued for 604 days respectively. In addition, power cuts continued for more than 684 days, water was cut for 174 days respectively. The number of victims due to the siege has reached to 172 victims.*
- *80,000 Palestinian Syrian refugees escaped from Syria to the neighboring towns, including 10,687 refugees in Jordan, 51,300 in Lebanon and 6,000 refugees in Egypt, according to UNRWA statistics till February 2015.*
- *Al Husayneyya Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 506 days respectively.*
- *Al Sbeina Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 475 days respectively.*

- *Handarat Camp: - Residents have left the camp for 677 days after the Syrian Opposition Groups controlled it.*
- *Dara'a Camp: - It is now almost 321 days without water and 70% of its buildings were demolished.*
- *Jermana, AL SaiedaZainab, Al Raml, Al Aedein Camps in Homs and Hamma: - A relatively quiet situation in light of the economic crises.*
- *Khan Al Sheih Camp: - Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.*
