### *"The AGPS: 65 Palestinian Refugees Died during April 2015, and Tragic Conditions to the Palestinian and Syrian Detainees in Macedonia, Drunken Police, and Sexual Harassment"*

### **Statistics**

*The AGPS documentation and monitoring team announced that 65 Palestinian refugees died during April 2015, including 32 refugees died due to gun shot, 9 refugees died due to shelling and clashes, 9 refugees died due to torture in the prisons of the Syrian Regime, 3 refugees died due to siege and lack of medical care, 3 refugees died due to unknown reasons, one refugee was drowned, and 3 refugees were killed after being kidnapped.*

*Meanwhile, the team documented the names of 6 Palestinian refugees died in Syria since the beginning of May 2015; they are: Raghad Khalid, 22 years, Haidar Ahmed Haidar, 13 years, IbrahimMajed Mohammed, from Yarmouk, Mohammed NemerHamoud, from Handarat Camp, Mohammed Rashid Al Saadi, from Al Maidan Neighborhood in Aleppo, and two PFGC members; they are: AbdulrahmanSayel and Mohammed Zaghloul.*

### **Macedonia**

*The AGPS received a message from number of Palestinian and Syrian detainees inside Ghazi Baba camp in Macedonia, which described their suffering inside this camp that is similar to a prison.*

*The detainees confirmed, in their message, that there are number of Syrians, Palestinians, Iraqis, and Afghans inside the prison, and they are suffering of dire situations. There is no room for sleeping for everyone; they are 27 in a room that contains only 10 people, while a number of*



*them are sleeping in the corridors, near the garbage containers, or near bathrooms.*

*The message indicated that the police do not provide them any services, they are drunk most of the time; drink wine, they only came to turn off lights, get back to their offices, and call some of the detained ladies to the investigation individual room and sexually harassed her.*

*In addition, there are families have young children aged between days to months, while the police beats the detainees, and calls them criminals, killers, and terrorists.*

*The residents stressed in their message that there no hygiene services, no doors for bathrooms, no hot water for showering, no boilers, while the prison administration prevents them of having food and clothes, as some of them are detained for more than five months. Food only includes one loaf of bread, a can of ton or sardines for each person, as well as the water is contaminated and they have to buy water and food with high prices.*

*Moreover, there are a lot of patients some of them are suffering asthma, hypertension, diabetes, and one of the detainees has functional loss of one of the testicles, one of the detainees was shot on his hand and hit his hand which cause gangrene and was amputated.*

*As well as, they are not allowed to go out to breathe only women, children, or anyone who forced to take the garbage out and return immediately. All detainees do not know the reason of their detention neither when they will be transferred to the court.*



*A lot of people are banned to connect with their relatives in order to tell them about their presence in this prison even in the presence of the police .*

*Stressing that they are not criminals and thieves, not terrorists, they are only illegal immigrants escaped from the conditions of war in their country in search of a better life".*

*They also renewed their appeals to human rights organizations, international organizations, ICRC, and Palestinian embassies, which is the only legitimate representative of the Palestinian people, to do their part and put an end to their suffering.*

*It is worth mentioning that the AGPS published during the past months, dozens of appeals by detainees in Macedonian prisons which calling for their release and for putting an end to their tragedy.*

### ***Recent Updates***

*Warplanes hovered above the Yarmouk refugee camp south of the Syrian capital Damascus, coincided with violent clashes between the Palestinian armed groups and ISIS alongside Al Nusra Front. The clashes centered at Al Habeib Mustafa mosque, Al Mahkama area, and Ein Ghazal Street, while ISIS groups are still control almost 70% of the camp. Meanwhile, civil committees and bodies in the Yarmouk launched a campaign for cleaning the streets and lanes of Yarmouk under the title of "We are Yarmouk," the campaign will be continuing for the next week.*





*It was mentioned that the Regular Army and PFGC groups are still imposing strict siege on the camp for 677 days, amid water and power cut all over the camp, which exacerbated the living situations.*

*In Damascus suburb, heavy shelling targeted the adjacent farms of Khan Al Shieh camp, where news reported a number of victims. The shelling coincided with sounds of violent clashes at the vicinity of regiment 137.*

*Meanwhile, in a state of panic and tension prevailed Khan Al Shieh camp for fear of shelling that may target the camp which is inhabited with residents in addition to hundreds of displaced families from the Palestinian refugee camps because of the shelling and siege.*

*On the other hand, the residents of Deraa camp are suffering of difficult humanitarian conditions due to lack of necessities of life and scarcity of food, medicine, and baby milk, as well as the continued power and water cuts for more than 382 consecutive days.*

*In Damascus suburb, a state of resentment and discontent spread among the people of Khan Dannon camp in the capital Damascus because of the*



*great neglect of the camp and its services, where people suffer from poor infrastructure services, high prices and the continuation of electricity, water and communications cut off for long periods of time. They also suffer of unemployment because of the continued war in Syria, as they complain of the Palestinian factions and UNRWA negligence to their camp, while they depend on financial and relief assistance provided by the latter between now and then.*

*It should be noted that the residents of the camp have previously directed several calls for UNRWA and for those responsible to repair the sewage problem that residents of the camp suffered for many days, but no one lifted a finger, according to a resident description.*

### ***Egypt***

*The Egyptian coast guard forces announced that three illegal emigrants died after their boat drowned near Al Buhaira province coasts. They indicated that the three emigrants are a man, a woman, and a child, while their nationalities are not known yet. The Egyptian coast guards managed to rescue another 31 emigrants from different nationalities, including Syrians and Sudanese who were aboard the same boat.*





### **Lebanon**

*The Palestinians of Syria Workers League held its first session in Sidon city in Lebanon on Sunday under the title "Challenges and Achievements." The session was sponsored by I.PAL.S.C, where the Palestinian workers expressed their continuing mobility support for Palestine cause and provide what they can to serve their Palestinian refugees people from Syria in Lebanon to ease the asylum pain and calamities inflicted on the Palestinian Syrians.*

### **Numbers and Statistics till 30/4/2015**

- *At least 27933 Palestinian Syrian refugees have reached Europe during the last 4 years.*
- ***The Yarmouk Camp:** - Siege, imposed by the Regular Army and PFGC, continued for 676 days respectively. In addition, power cuts continued for more than 746 days, water was cut for 236 days respectively. The number of victims due to the siege has reached to 176 victims.*

- **80,000** Palestinian Syrian refugees escaped from Syria to the neighboring towns, including **10,687** refugees in Jordan, **51,300** in Lebanon and **6,000** refugees in Egypt, according to UNRWA statistics till February 2015.
- **Al Husayneyya Camp:** - Regular Army is still preventing the residents of the camp to return back to their houses for **566** days respectively.
- **Al Sbeina Camp:** - Regular Army is still preventing the residents of the camp to return back to their houses for **537** days respectively.
- **Handarat Camp:** - Residents have left the camp for **739** days after the Syrian Opposition Groups controlled it.
- **Dara'a Camp:** - It is now almost **383** days without water and **70%** of its buildings were demolished.
- **Jermana, AL SaiedaZainab, Al Raml, Al Aedein Camps in Homs and Hamma:** - A relatively quiet situation in light of the economic crises.
- **Khan Al Sheih Camp:** - Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.
