### ***Victims***

*The refugee "Mohammed Sweid" from Nairab camp died after drowning in a lake in Germany.*

*It is worth mentioning that the UN High Commissioner for Refugees (UNHCR) announced earlier that the number of Palestinian Syrians refugees who arrived to Europe through the past four years has exceeded 36,000.*

*The First Lieutenant "Mohamed Khair HALawa," a PLA officer, died after violent clashes in the town of Adra Sin Damascus suburb after groups of the Syrian armed opposition attacked a PLA point in Adra.*

### ***Recent Updates***

*Yarmouk camp for Palestinian refugees was exposed to bombing with number of shells that targeted separate areas of the camp.*



*The shells didn't lead to casualties. The residents of Yarmouk are still suffering of the strict siege that is imposed since 769 days respectively by the PFGC and the Regular Army. The siege resulted in the lack of the basic needs and the lack of medicine and medical materials. In a different context, Al Wafa European campaign started to distribute food aid on the residents of the Yarmouk camp and the displaced people at Yelda town near the camp.*

*In related context, activists in the Yarmouk camp insured the spread of Typhoid and Jaundice inside the besieged camp especially amongst children.*

*It is worth to mention that activists appealed earlier the international and Human Rights organizations such as ICRC and the SRCS to enter the medicine to the Typhoid and Jaundice diseases to the besieged camp.*

*On the other hand, two female children Jana and Judi Rafi Rafi from Al Nairab camp were injured due to mortar shells that targeted their house in Aleppo, and they were transferred to a hospital to get treatment.*



*According to their father Rafi Rafi said that their injury is not dangerous and they are in good health. It is mentioned that many of the Al Nairab camp residents were obliged to leave the camp due to the deteriorated security and economic situation and the continuation of war in Syria and its negative impact on the reality of the Palestinian refugees such as murder, arrest, and damaging of houses.*

*The suffering of the Palestinian refugees of Handarat camp, who left since 829 days respectively due to the control of the Opposition on their camp, continues. The residents of the camp face cruel living conditions especially after they were requested to leave the Ninth Unit that they live in at University City in Aleppo, which increased their suffering.*

*Handarat camp and the surrounding areas are still exposing to bombing and violent clashes between the Syrian Opposition and the Regular Army alongside Al Quds Brigade, where the Regular Army seeks to control the camp which forms a strategic point for it. The Syrian Opposition forces seek to proceed to Handarat town and Aleppo central prison.*



*The AGPS documented about 43 victims died from Handarat camp and 32 detainees from the residents of the camp in the Syrian prisons.*

### ***Numbers and Statistics till 9/8/2015***

- *15,500 Palestinian Syrian refugees in Jordan, 45,000 Palestinian Syrian refugees in Lebanon, and 6,000 refugees in Egypt, according to the UNRWA's statistics till July 2015.*
- *At least 36,000 Palestinian Syrian refugees have reached Europe during the last 4 years.*
- *The Yarmouk Camp: - Siege, imposed by the Regular Army and PFGC, continued for 768 days respectively. In addition, power cuts continued for more than 838 days, water was cut for 328 days respectively. The number of victims due to the siege has reached to 177 victims.*
- *Al Husayneyya Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 649 days respectively.*
- *Al Sbeina Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 630 days respectively.*
- *Handarat Camp: - Residents have left the camp for 831 days after the Syrian Opposition Groups controlled it.*
- *Dara'a Camp: - It is now almost 475 days without water and 70% of its buildings were demolished.*
- *Jarmana, AL Saieda ZAinab, Al Raml, Al Aedein Camps in Homs and Hamma: - A relatively quiet situation in light of the economic crises.*

- *Khan Al Sheih Camp: - Roads linking the camp to the city center are still closed except for Zakia- Khan Al Shieh road.*
