"AGPS in Syria Calls for Lifting the Restrictions on the Free Movement of Palestinian-Syrian Refugees"

Recent Updates

AGPS issued a press statement calling for lifting the restriction on the free movement of Palestinian-Syrian refugees, confirming that the Palestinian-Syrian refugee still has no entry for almost all of the Arab and Islamic countries such as: Lebanon, Jordan, Egypt, Arab Maghreb States, and Turkey unless they meet the onerous conditions which are not allowed for the majority of refugees.

The statement considers that, it would constitute a flagrant violation of fundamental rights enshrined in the Universal Declaration of Human Rights such as Article 13, second paragraph, which states "everyone has the right to leave any country, including his own, and the right to return as well " also Article 14, first paragraph: "Everyone has the right to resort to another country escaping the persecution".



The statement confirmed that, those decisions and actions resulted in many deadly incidents where the Palestinian refugee Basil Azzam has been killed in bombing in Idlib city after being detained for months at the Ataturk Airport, and then deported by the Turkish authorities to the Syrian border. However, the hunger strike was not enough for him to get



into Turkey and he was returned to Syria in loud and clear violation of international refugee Convention which ended with his death.

AGPS confirmed in its statement that, it views with concern for the fate of individuals, and the Palestinian-Syrian refugee families, who stuck in the airports and borders. Also it invites the concerned States to allow the Palestinian-Syrian refugees to enter its territory immediately and provide the necessary facilities for the sake of safe life away from the war and life-threatening.

The AGP also assured on the need for the Palestinian Authority and its embassies to carry out the needed diplomatic work to lift restrictions on free movement of Palestinian refugees in the Arab and Islamic countries, beginning from the international treaties and conventions, which provide the human right of movement..

The AGPS also appealed the the Arab League to activate the white house Protocol, which regulates the Palestinian presence within the Arab states .also it called the international community and all governmental and non-governmental institutions to support the Palestinian refugees' right of movement and residency and work where ever they are..

On the other hand, the Lebanese security asked the Palestinian-Syrian family that- has been deported from the "Carthage" Airport yesterday morning, to revise within 72 hours without giving any details, and that after they were allowed to leave the airport # Beirut.

After that, the Tunisian authorities have deported the family who was stuck in Carthage airport, where the family was on her way toward Mauritania, coming from Beirut airport, which is composed of three

members, including a one-year old child, knowing that they were legally left the Beirut airport to Mauritania through Tunisian airline.

In spite of the appeals launched by the family through the working group for the Palestinians in Syria and human rights on all sides, the Palestinian Liberation Organization, the Palestinian factions and the embassy in Tunis # to stop their deportation from Carthage Airport.



Moving to Syria, a violent air strikes- launched by Russian and Syrian warplanes- resulted in the destruction of the statues of Alawda martyrs in Khan-Sheih camp, as warplanes also targeted Alsalam hospital and Makhfr Street, causing substantial damages in the place..





While AGPS activists confirmed that, the systematic bombardment of Khan-Sheih camp targeted primarily infrastructure, schools and clinics, noting that the bombing resulted in the destruction of large parts of the neighborhoods and alleys, warning of a plan to evacuated the camp and destroy it completely.

In the Yarmok camp, "ISIS" continue imposing a tight siege on dozens of families living in areas under the control of the "Fath-Sham" or Nosra groups for the fifth day respectively, whereas the siege is concentrated in Rija area, Ain Ghazal and Haifa Streets.

"ISIS" prevent the entry of food into the Camp, after a decision by the organization last Friday morning in an attempt to put pressure on the "Fath-Sham" fighters to leave the camp..

More than fifty families of civilians from the people of those areas are living in the camp, as well as to the families of the "Fatah al-Sham" fighters, while teachers who work in schools are the only people allowed to get in and out the camp..

The people of Ain Ghazal and the areas under the control of the "Fath-Sham" faction in the Yarmouk refugee camp, warned of the consequences of the blockade imposed by "ISIS", which resulte in victims due to of hunger and lack of nutrition by these arbitrary actions against them.

Borders

Jordanian and Turkish authorities continue to prevent the entry of Palestinian-Syrian refugees to their territory, and in spite of the text of all



the international conventions that require -all neighboring countries, to countries of war- to receive the refugees without any restrictions. Whereas Turkish embassy stopped issuing visas to Palestinian-Syrian for more than three years ago, without giving any reasons for this, in the case of the Jordanian government issued a formal decision prevents the entry of Palestinian-Syrian refugees to Jordan for any reason..

As the Lebanese authorities to tighten procedures for the entry of Palestinian-Syrian refugees into their territory, multiple sources of the working group for the Palestinians in Syria confirmed that the Palestinian refugees access to Lebanon is extremely difficult and temperamental, where they allow some of them, and refuse the others despite that almost of the cases have all required papers by the Lebanese border guards.

Civil Work Committees

Furqan Society for charity work continues to distribute aid on the Syrian and Palestinian-Syrian families who were displaced to Ein-Elhelwa Camp in Sidon city, southern Lebanon. According to those in charge of Assembly, during the seventh of this year, they contributed in hospitalization for a number of the displaced families from Syria, also the society distributed food parcels to the families who just arrived the camp in addition to providing aids such as blankets, and bed sheets, as well as helping a family who has got its house completely burned in the Arab-Ghuwair neighborhood.



It is noteworthy that, 870 of about 12 thousands of the Palestinian-Syrian families who live in Ein-Helwa Camp have been evacuated to Lebanon escaping the ongoing war in Syria.



Palestinians of Syria; Numbers and Statistics till 10\08\2016:

- *15500 Palestinian Syrian refugees are in Jordan*
- *42.500 Palestinian Syrian refugees are in Lebanon*
- *6000 Palestinian Syrian refugees are in Egypt, according to the UNRWA statistics till July 2015*
- *8000 Palestinian Syrian refugees are in Turkey*
- *1000 Palestinian Syrian refugees are in Gaza*
- *More than 71.2 thousand Palestinian Syrian refugees have reached Europe till the End of December 2015*
- *The Yarmouk Camp: siege, imposed by the Regular Army and PFGC groups, continued for 1149 consecutive days. Power cut continued for more than 1210 days, water was cut for 699 days respectively. The number of siege victims is 187.*

- *Al Sbeina Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 1002 days respectively.*
- *Handarat Camp: - All Residents have left the camp for about 1 194 days after the Syrian Opposition Groups controlled it.*
- *Dara'a Camp: - It is now almost 853 days without water and almost 70% of its buildings were demolished.*
- *Jermana, AL Saieda ZAINAB, Al Raml, Al Aedein Camps in Homs and Hamma: - A relatively quiet situation in light of the economic crises.*
- *Khan Al Sheih Camp: - Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.*
