## Latest Developments

Palestinian refugee Reyad Bashir AlKhatib, who was displaced from Yarmouk Camp, in Damascus, to Efrin, in northern Syria, succumbed to wounds he sustained after he was shot on June 6 by anonymous assailants in Efrin.

The refugee breathed his last at a Turkish hospital on Monday.

An activist told AGPS that three gunmen opened fire at a Palestinian refugee outside of his home over allegations that he has been releasing counterfeit reports about the transfer of Palestinian refugees to northern Syria. The refugee sustained skull fractures and was rushed to a Turkish hospital.



Last week, the Documentation Center of Palestinian Refugees denied reports about underway attempts to transfer Palestinian refugees to northern Syria.

The statement came in response to reports released by the The Violations Documentation Center (VDC) about the projected settlement of 1,500 displaced Palestinian families in Efrin.

The Documentation Center of Palestinian Refugees slammed the report as “politicized”, saying VDC has not reached out to reliable parties before publishing the counterfeit news on its website.

In another development, residents of Daraa Camp for Palestinian refugees, south of Syria, have lodged applications for compensation of property damage caused by the eight-year warfare. The applications have been deposited at the office of the General Authority for Palestinian Arab Refugees, in AlKashef neighborhood, in Daraa city.



An AGPS field reporter said title deeds evidencing the right of ownership to the damaged building, along with a request to the Attorney General in Daraa and proof of residence documents should be submitted with the application. The applicants should then show up at the police station for a formal record of evidence.

Meanwhile, residents of AlSabina Camp in Rif Dimashq continue to rail against the poor hygiene and mismanagement at Muadh Ibn Jabal Mosque.

Speaking with AGPS the worshipers said the call to prayers has not been recited via the mosque loudspeakers for over a week's time over allegations of repairmen works.

The locals called on the Ministry of Endowment in Damascus and all other concerned authorities to monitor the performance of the mosque committee and take necessary measures in response to the poor management at the holy site.



Located some 14 kilometers away from southern Damascus, AlSabina Camp has been gripped with an abject situation owing to the absence of humanitarian assistance, relief aids, proper infrastructure, and vital facilities.

In the meantime, the family of Palestinian refugee Ahmed Khalil Ibrahim, called Abu AlEz and born in Damascus on November 16, 1974, has appealed to the international human rights institutions, namely Amnesty International, and the Greek authorities to work on disclosing the fate of their relative, who has gone missing in Greece.

The family said Ahmed, a resident of Shabaa town, in Ghouta, mysteriously disappeared from Athens more than 30 days ago. His condition and whereabouts remain unknown.

Along the same line, Palestinian refugee Bashar AlAssaad, a resident of AlNeirab Camp, in Aleppo, has been enduring a mysterious fate in Syrian state jails, where he has been locked up for the 7th consecutive year.

Bashar was arrested by Syrian government forces on November 28, 2012 as he took part in protests staged in response to the checkpoints pitched around the camp. His family continues to appeal for information.

AGPS calls on the Syrian government to disclose the fate of hundreds of Palestinians forcibly disappeared in state-run dungeons.

AGPS believes that the arbitrary internment of Palestinian refugees in war-torn Syria amounts to a war crime.

AGPS kept record of several cases where Palestinians have been kidnapped at government checkpoints or during assaults carried out by government troops on Palestinian refugee camps and shelters.
