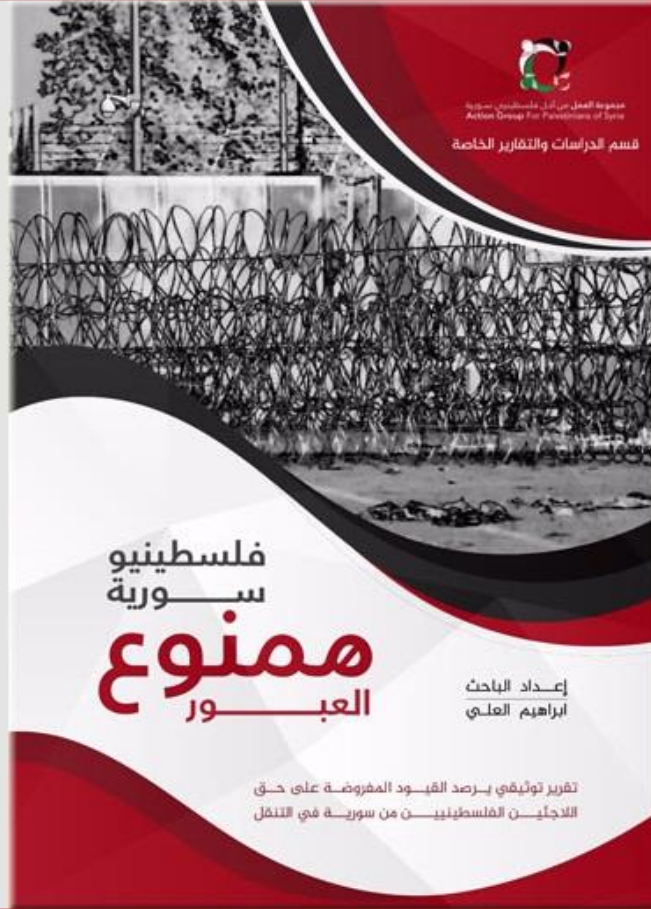

Victims

Palestinian “Samer Waareya” from the Handarat refugee camp, and a member of the “Liwaa Al-Quds” battalion, has died while fighting alongside the Syrian regime forces, in the ongoing clashes in Deir ez-Zour, in the east of Syria.

On its part, AGPS confirmed that it recorded the data of 626 Palestinian refugees, who have died while fighting alongside the Syrian regime forces.



Latest Developments

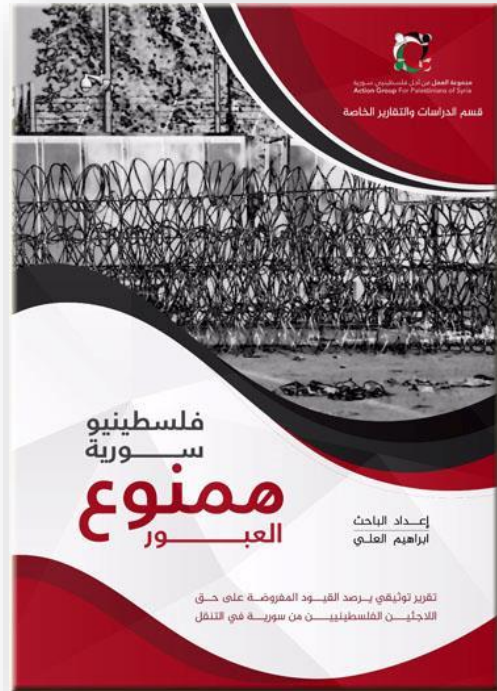
Within its series of periodic reports on the situation of Palestinian-Syrian refugees, AGPS published a documentational report titled, “Palestinians of Syria No Crossing.” The report monitor the violations which have affected one of the most important of the Palestinian refugees’ rights, that is the right of movement, which is guaranteed by the Universal Declaration of Human Rights and the international agreements and conventions, by comparing the practical reality of their treatment and the mechanisms by which the

countries with common borders with Syria have dealt with the refugees, to the theoretical texts included in those conventions.

The 28-page report also discusses the most important violations and incidents that have affected the Palestinian-Syrian refugees in Syria, and the limited mobility and immigration outside of Syria. The Palestinian refugees in the cities and suburbs of Syria, have suffered from an almost total disability in mobility, whether while fleeing their camps that are under the fire of the Syrian regime's forces and their explosive devices, or leaving and entering through their areas for hospitalization and to get access to the essential food supplies needed for the integrity of life.



The fixed or moving barriers put by the Syrian regime, on the gates of the cities, towns and roads, limited their movement, as well as being a main reason for the aggravation of the tragedy and suffering of the Palestinian refugees, through what they were subjected to including tightening, the siege, extortion, harassment or arrest, in a clear violation of the international conventions and agreements on civil and political rights, which gave them the right to move freely and choose their of place of residence within the country in which

they live. “Everyone who has a legal status within the territory of a country, has the right to the freedom of movement and to choose their place of residence.”

The report also addressed the situation of the Palestinian refugees and the limited mobility or immigration to outside of Syria, since most of the countries worldwide, have limited have banned the entrance of Palestinian refugees to their lands, without prior access to a "visa" in the normal circumstances. This situation has not changed or been amended, due to the situation in Syria regarding the Palestinian refugees, who found themselves in desperate need of moving and traveling, after their camps were subjected to a total siege or partial destruction, and the loss of security. The conditions for obtaining permission to enter have become more complicated and tougher.

In another context, our reporter in Yarmouk camp confirmed the presence of sharp differences between members of ISIS inside the camp, because of the divisions over the distribution of positions among the leaders of the organization.

Our correspondent reported the news of an infiltration attempt by the members of ISIS, the day before yesterday, to one of the points controlled by “Hayat Tahrir Al-Sham,” (previously Al-Nusra Front), leading to the break out of clashes near the residential blocks adjacent to Street 15, in the direction of the Zeid ibn Al-Khattab Mosque, which is located in the area controlled by the “Hayat.”

However, its members managed to abort ISIS's attempt to infiltrate and break into the area, while there were several injuries on both sides.

In south Syria, low temperatures have exacerbated the suffering of the Palestinian-Syrian refugees in general, and in Deraa camp, Al-Sad Road and the Zayzoun camp in particular. The suffering has compounded because of the severe scarcity of fuel for heating, in addition to the loss of dozens of families to their homes because of the war. Most of them have to live in tattered tents that do not protect them from the winter.

According to our correspondent, the price per liter of fuel has reached 400 Syrian pounds, the price of one cylinder has reached 9500 Syrian pounds, and as for the price of firewood, one ton has amounted to 100 thousand Syrian pounds.

In another context, the Deputy Director General of UNRWA in the near east, Lex Takkenberg, visited the Handarat refugee camp on Monday 11-12.

During his visit with Michael Amania and Mervat Abu Rashid, the agency's Director in Aleppo, observed the scale of the destruction suffered by the camp, as well as visiting a number of families who had lately returned to their destroyed houses, after giving up in finding a shelter, and especially after being forced to evacuate the ninth unit of the university housing in Aleppo, and after losing hope for the intervention of UNRWA and the concerned parties to rehabilitate it.

On their part, a number of activists and residents of the Handarat camp, called on UNRWA to rebuild and return them to their homes, which they were forced to leave.

Palestinians of Syria: December 12, 2017 Statistics:

- The total number of victims documented by the Action Group is 3615, including 463 women
- 1644 Palestinians are locked up behind Syrian government's bars, 106 of which are women
- Yarmouk refugee camp is under the Syrian regime army and Popular Front for the Liberation of Palestine's siege for 1,609 days in a row
- 204 refugees, mainly in Yarmouk Camp, have died due to lack of medical care and malnutrition
- Water supplies have been cut off Deraa Camp for 1346 days, and 1186 days in Yarmouk Camp

- Residents of Handarat Camp, in Aleppo have been banned from their homes for 1,682 days. Government troops have taken over the camp for more than 445 days.
- Approximately 85 thousand Palestinian-Syrian refugees fled to Europe by the end of 2016
- 31 thousand refugees are located in Lebanon
- 17 thousand refugees are sheltered in Jordan
- 6 thousand refugees are in Egypt
- 8 thousand refugees are staying in Turkey
- One thousand refugees are present in Gaza
