### ***Victims***

*The Refugee "Mohammed Mustafa" died due to the lack of nutrition and medical care because of the siege imposed on the Yarmouk by the regular army and the PFGC groups for 558 days, bringing the siege victims' toll to (160) victims.*

*It is noteworthy that the regular army and the PFGC checkpoints prevent the entry of food, medical supplies and fuel to the camp, which has led to widespread of starve and acute shortage of medical services.*

*The AGPS received news about the death of the Palestinian refugee "Hisham Azzam" from the Yarmouk refugee camp due to torture in the prisons of the Syrian regime, bringing the torture victims' toll to (288), according to the AGPS documentary Statistics.*

*Meanwhile, the PFGC announced, on Facebook, the death of "Nidal Aldahok", One of its members, due to wounds he sustained earlier, it is mentioned that the PFGC is a pro-Syrian regime faction fighting for his part, since the start of the events in Syria.*

### ***Recent Updates***

*Bodies and institutions, that work in the Yarmouk camp launched a distress call, the AGPS received a copy of it, to appeal the humanity, the governments of civilized nations, the United Nations, the Security Council, UNRWA, the PLO, the Red Cross, Red Crescent, and free and honorable men of the Islamic and Arab world to stop the crazy war machine, demanding that they should come to the aid of the camp.*

*Institutions also referred to the living conditions in the camp, where it mentioned in the appeal, " food ran out and we eat grass, potable drinking water ran out, while God has blessed us with ice water to drink, in addition to the power outages, lack of fuel for heating and cooking, lack of medicines, vaccines and baby milk, suspension of humanitarian aid after booked outside the camp.*

*We became surround by starvation, bodies became scrawny, women aborted, children and elderly died, epidemic diseases spread, severe stress, deadly hunger, thirst and cold, , and our presence in our camp is a symbol and a witness to the Zionist crimes in our disastrous Nakba and adherent to the right of return to our homeland Palestine.*

*This came during the bodies and institutions implementation of a sit-in in front of the youth support center, to protest against the continuation of the ongoing siege of the camp for more than a year and a half, and to the suspension of entering food aid .*

*In the same context, a number of Palestinian activists from the Syrian Palestinian camps launched campaign titled "Save Palestinians of Syria", in order to open a safe humanitarian corridor under the protection and care of the international organizations to take, all those who wish, out of the Palestinians of the Yarmouk, Sbeineh, Husseinia, and Al Sayeda Zainab camps, who are besieged, out of conflict and war zones, to initiate a secure and stable life.*

*On the other hand, the regular army and PFGC groups checkpoints, which surrounded the Yarmouk refugee camp for more than a year and a half, allowed the exit of five medical conditions, in order to complete their treatment in hospitals outside the camp.*

*It is noteworthy that all the hospitals in the camp stopped working due to the lack of materials and medical staff with the exception of Palestine Hospital, which offers some simple medical services for the trapped people.*

*It should be noted that the Yarmouk camp is still besieged by the regular army and the GC groups for 558 days respectively.*

*As the residents complain of the continued power outages for more than 638 days, and water for 128 days respectively, while (160) refugees died because of the siege and the lack of medical care.*

*In Damascus suburb, powerful voice explosions rocked Khan Al Sheih camp, causing panic among the residents, especially the children and women, were later found to be resulted in the bombing of surrounding areas by warplanes.*

*Meanwhile, our correspondent reported that residents of Khan Al Sheih camp living harsh humanitarian conditions as a result of food shortages and the lack of fuel, forcing them to resort to use firewood, which is sold at high prices, invoking a number of families, who suffer from economic miserable conditions, to burn some of their clothes and furniture.*

*In Homs, Syrian security checkpoints allowed, on Wednesday, to enter amount of firewood and cooking gas to Al Aedein camp in Homs, after one week prevention, while the people in the camp are suffering from a severe shortage of heating materials, which exacerbated the suffering in*



*recent months, especially with the low temperature which affected the region in the past few days.*

*The people also complain of the checkpoints security tightening, which controls the road leading to the camp, prompting many youth, who are in the age of compulsory service, to leave the camp to Turkey and from there to the Nordic countries, for fear of being forced into military service in Palestinian Liberation Army.*

*On the other hand, warplanes hovered above Muzeireeb compound in the province of Daraa, a city of about eight thousand five hundred Palestinian refugees, accompanied by strong clashes voice echoed throughout the town, resulted in a state of tension and anger among the residents for fear of repeating bombing with explosive barrels, which affected the compound earlier, that led to the death of a number of civilian casualties. The shelling targeted the vicinity of a children school several months ago and resulted in casualties among civilians, mostly children.*

*As in Lebanon, Women's Committee of the Palestinians of Syria Commission in Lebanon, carried out a field visit included some of the camps and compounds inhabited by Palestinians of Syria in Lebanon's at Biqaa region, in order to inspect the human and living conditions and to provide a helping hand to them, especially in light of low air and heavy snowstorms.*

*The Women's Commission distributed fuel, heaters, winter blankets, shoes and diapers on a number families affected by the snowstorm, as the doctor a member of the Women's Committee - has inspect and examine a number of patients in these compounds and camps.*

### ***The Palestinian Camps in Syria, Numbers and Statistics till 14/1/2015:-***

- *At least 27933 Palestinian Syrian refugees have reached Europe during the last 4 years.*
- *2600 Palestinian refugees were documented by the AGPS including 157 women, 286 were killed due to torture, 267 were killed by sniper shot, 84 refugees were field executed, and 985 refugees were killed due to bombing.*
- ***The Yarmouk Camp:** - Siege, imposed by the Regular Army and PFGC, continued for 558 days respectively. In addition, power cuts continued for more than 638 days, water was cut for 128 days respectively. The number of victims due to the siege has reached 160 victims.*
- *80,000 Palestinian Syrian refugees escaped from Syria to the neighboring towns, including 14348 refugees in Jordan, 42,000 in Lebanon, according to UNRWA statistics till November 2014.*
- ***Al Husayneyya Camp:** - Regular Army is still preventing the residents of the camp to return back to their houses for 460 days respectively.*
- ***Al Sbeina Camp:** - Regular Army is still preventing the residents of the camp to return back to their houses for 429 days respectively.*
- ***Handarat Camp:** - Residents have left the camp for 631 days after the Syrian Opposition Groups controlled it.*
- ***Dara'a Camp:** - It is now almost 275 days without water and 70% of its buildings were demolished.*
- ***Jermana, AL SaiedaZainab, Al Raml, Al Aedein Ca mps in Homs and Hamma:** - A relatively quiet situation in light of the economic crises.*
- ***Khan Al Sheih Camp:** - Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.*
