Latest Developments

Calm has been restored in southern Syria after the end of clashes between local armed groups and ISIS militias in AlSadd neighborhood, in Deraa.

A number of Palestinian refugee families who fled the adjacent Deraa Camp and AlSadd returned to their houses in the area.

Local sources said several dead bodies covered with dust have been spotted in the area.

At least 45 Palestinian families, including 15 from Deraa Camp, fled to neighboring areas as violence went unabated last week.

In another development, internal dissent has been reported among members of Liwaa AlQuds group, affiliated with the Syrian regime, over affiliations with Russia or Iran in Syria.

The pro-Russia division at Liwaa AlQuds is led by commander Mohamed AlSa'id. The group's pro-Iran division is led by Reyad AlKhatib. Both are residents of AlNeirab Camp, in the northern Syrian city of Aleppo.

Another division, led by Mohamed AlSaid's deputy, Adnan AlSayed, has equal ties with Russian and Iranian forces. The pro-Russian side is reportedly the strongest.

In the meantime, the Quds Charity, in partnership with the General Authority for Palestinian Arab Refugees (GAPAR) announced the launch of free medical days in AlRamadan Camp for Palestinian refugees, in Rif Dimashq, on November 16-17.

Residents with digestive, gynecological and/or pediatric diseases can show up at the facility from 10 a.m. until 02 p.m. for a free medical diagnosis.

The Quds charity also launched a campaign to collect cash and in-kind aid items to vulnerable families.

In the meantime, the political advisor to the Palestinian Minister of Foreign Affairs and Expatriates, Ambassador Ahmed Al-Deek, said that DNA samples taken from the families of missing Palestinians arrived in Tunisia yesterday.



This comes after dead bodies of migrants were spotted off Tunisian coast.

A few days earlier, activists launched an appeal to identify the fate of the missing Palestinian Muhannad Muhammad Attia, who was on board the boat that sunk off the Tunisian coast of Zarzis.

Muhannad was raised in Yarmouk Camp for Palestinian refugees, in Damascus, before he fled to Lebanon. Palestinian refugee Muhammad Mahjoub Abdullah, born on

15/6/1984, and holding Syrian travel documents, was also on the missing list. The Libyan authorities are detaining two Palestinian-Syrian migrants who survived the boat tragedy.
