Latest Developments

AGPS kept record of 15 cases of death under torture in Syrian government jails among Palestinian refugees. The latest victim is identified as Ramzi Hasan AlAweimar AlNa'imi, a resident of Daraa Camp. He was arrested by the air intelligence forces in Rif Dimashq in 2013. He reportedly died in June 13, 2014.



Along the same line, Palestinian refugee Mohamed Kheir Suleiman and his sons, Nayef and Ahmed, have been enduring mysterious fates in Syrian penitentiaries for six years running.

The father and his two sons were kidnapped by Syria's pro-government militias and their war-partners at Yarmouk checkpoint in January 2013. Their family continues to appeal for information.

AGPS documented the secret incarceration of 1,757 Palestinians in Syrian government jails, among whom 108 women and girls.

In another development, residents of Khan Dannun Camp, in Rif Dimashq, have spoken out against the mistreatment they have been subjected to by staff members at a UNRWA-run clinic in the camp.



Local activists urged the UN refugee agency, the General Authority for Palestinian Arab Refugees, and all other concerned authorities to take immediate action in response to the mistreatment they have been facing at the UNRWA clinic.

In a statement emailed to AGPS, the residents slammed the medical staff at the clinic for their apathy regarding the appeals of a number of mothers and their children for much-needed treatment and medicines, along with psychological support.

In the meantime, UNRWA has transferred cash aids for the Palestinians of Syria in Lebanon via ATM cards.

Every Palestinian family from Syria received a rental allowance of \$100 and a food allowance worth 27\$ per every refugee.

Nearly 28,000 Palestinian refugees from Syria seeking shelter in Lebanon have been subjected to dire socio-economic conditions and a precarious legal status as the Lebanese authorities continue to rebuff their appeals for legal visas and access to the local labor market.
