"A Father and His Son Died Due to Airstrike in Al Nairab Camp"

Recent Updates:

Syrian warplanes targeted a wedding hall called -Rose- in Al Nairab camp in Aleppo, which led to the death of a father and son, in addition to a state of terror in the camp.

It is mentioned that the Regular Army is completely taking over the camp. During the last few months, the camp witnessed frequent clashes between the Regular Army and the opposition, while the camp is considered as a strategic area due to Al Nairab military airport.



In the south of the capital Damascus, in spite of the necessity of the urgent medication, an old man has been prohibited from leaving the Yarmouk camp – Daash controls wide areas of the camp and the old man lives in Al Nusra area. They prevented him to get out though the necessity to get immediate treatment because he has heart diseases..

The area that is under Al Nusra Front control is inhabited by more than 50 families , most of them are civilian, in addition to the fighters' families, where Dassh refused to supply the Camp with food in an attempt to put pressure on the fighter of Al Nusra " Fateh Al Sham" to leave the camp.



It comes with the continuing clashes between Dassh and Al Nusra Front in the Yarmouk camp, where Dassh is trying to dominate the camp. It is noted that fighters of Al Nusra Front have facilitated the entrance of Dassh to the Camp, in April 2015, while the siege that imposed by the Regular Army and the PFGC is still on the camp, in addition to the water and electricity shortage, and banning food, and medication.



In the meantime, Palestinian activists – through Facebook- confirmed that, the Regular Army has freed two Palestinian refugees who were detained two years ago, Ali Alterani (Abo Omar) and Bassam Abd Rahman (Abo Alaal), both of them are from Der'aa Camp in the south of Syria.

It is noteworthy that, AGPS has documented 1097 of the Palestinian refugees have been detained by the Syrian Regime since the beginning of the War in Syria, including women, children, and old men.

In Egypt, Palestinian-Syrian refugees confirmed that the Saudi Embassy in Cairo, refused to give them Visa to perform Hajj, through AGPS, a number of the refugees claimed that Saudi Embassy rejected them in despite of having the necessary documents, and Saudi authorities claimed that, there are orders not to give any Palestinian refugee the visa to perform Hajj.



Palestinian activists said that the Syrian Opposition Coalition in Egypt is responsible of the Hajj file for the Palestinian and Syrian refugees , claiming that the Palestinian-Syrian with their civil status are under the name of Syria.

Activists added that they contacted the Syrian Coalition in Egypt in order to solve the Hajj case, and, in turn, they sent a book to check with the Supreme Hajj Committee emanating from the coalition.

The Supreme Hajj Committee – according the signed conviction Hajj Ministry in Saudi Arabia- became responsible of facilitating Hajj procedures, preparing the required services to serve the pilgrims, including registration, application, issuing the required visas by Saudi Arabia Embassies, opening offices in Lebanon, Turkey, Egypt, Jordan, and Syria – areas under the control of the Opposition-, and following up the transportation, accommodation in Meka and the city, and the sacred ritual. .

Media resources confirmed that, the Saudi authorities issued a decision that prevents the Palestinians who live in Arab countries from performing Hajj and Omra, claiming that the decision is issued to prevent the entry of the terrorists to the Kingdom, assuring that the decision is only applied on the Palestinian.

It is noteworthy that thousands of the Palestinian refugees fled from Syria to the neighboring countries and to EU after being bombed and detained. The refugees – in the neighboring countries- are facing difficulties in terms of living and legal levels, due to not having any representative to follow up their affaires and needs.



AGPS documentation and monitoring team documented 3312 deaths of the Palestinian-Syrian refugees due to the War in Syria, where 1103 were killed in shelling, 766 were killed in clashes between the Regular Army and the armed opposition, and 448 were tortured to death.

Palestinians of Syria; Numbers and Statistics till 19\08\2016

- *15500 Palestinian Syrian refugees are in Jordan*
- *42.500 Palestinian Syrian refugees are in Lebanon*
- *6000 Palestinian Syrian refugees are in Egypt, according to the UNRWA statistics till July 2015*
- *8000 Palestinian Syrian refugees are in Turkey*
- *1000 Palestinian Syrian refugees are in Gaza*
- *More than 79,000 Palestinian Syrian refugees have reached Europe till mid 2016*
- *The Yarmouk Camp: siege, imposed by the Regular Army and PFGC groups, continued for 1159 consecutive days. Power cut continued for more than 1219 days, water was cut for 708 days respectively. The number of siege victims is 18%.*
- *Al Sbeina Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 1011 days respectively.*
- *Handarat Camp: - All Residents have left the camp for about 1202 days after the Syrian Opposition Groups controlled it.*
- *Dara'a Camp: - It is now almost 862 days without water and almost 70% of its buildings were demolished.*
