Mahmoud Mohammed Aweid Al Tillawi, Abu Muhammed, died due to the Syrian warplane shelling at Deraa camp south of Syria on Thursday-Friday with explosive barrels.

The Palestinian young man Ahmed Shihada Deiab from Jaramana Camp died while participating in the ongoing conflict in Syria.

Recent Updates

On the occasion of the World Refugee Day, the AGPS declared that it documented about 2889 Palestinian refugees, who died during the ongoing war in Syria, and it also documented 896 detainees in the Syrian prisons and 276 missed people.

The AGPS Statistics referred that 1009 refugees died due to the exposure of their houses to bombing while 618 refugees died due to clashes, 397 refugees died due to torture in the Syrian prisons, 277 refugees died due to sniping, where 177 refugees died due to the strict siege that is imposed



The UNRWA continued through its statement that Khan Al Shieh camp was hit by several explosive munitions over the course of the day on 16 June, first at around 01:00am by explosions believed to be caused by mortar shells. Then around 11:30am, the camp was hit by heavy munitions reportedly including at least one barrel bomb delivered by aircraft.

UNRWA deplores the loss of life, injuries and trauma inflicted on Palestinian civilians, including children. UNRWA is appalled by the explosion affecting United Nations premises and calls on all parties to this conflict to recognize and respect the sanctity, neutrality and inviolability of UN premises. UNRWA calls on the Government of Syria to ensure respect for and compliance with its obligations under international law. UNRWA also calls on armed groups in Syria to respect and abide by their international legal obligations. There must be an end to all actions that threaten the lives and wellbeing of Palestinian and Syrian civilians throughout Syria.

It is mentioned that Khan Al Shieh was exposed during the last three day to violent and frequent bombing with explosive barrels and artillery shells that led to victims and a number of injured people in addition to the destruction of houses and properties.

On a different context, a woman that was released earlier from the Syrian regime prisons called to help her in finding her three sons they are; the twins Jehad and Mohammed Nedal Shaath who were born in 1998 and her daughter Insherah Nedal Shaath who was born in 2000 after she was looking for them and hasn't found them due to bombing and displacement



of the area that they live in Al Kajar Al Aswad which surrounds the Yarmouk Camp south of Damascus.

On the other hand, a number of activists in Khan AL Shieh camp for Palestinian refugees in Damascus suburb launched a campaign on the social media website Facebook demanding to release the detained people of Khan Al Sheih camp from the Syrian regime prisons, where the activists raised banners demanding to release their relatives, they wrote on the banners” Where is my Detained Brother? I am the Detainee Don’t Forget Me.



It is worthy to mention that the AGPS documented the information of 896 Palestinian detainees in the Syrian Regime’s prisons.

Numbers and Statistics till 20/6/2015

- *80,000 Palestinian refugees escaped from Syria, including 10,687 refugees in Jordan, 51300 refugees in Lebanon, and 6,000 refugees in Egypt, according to the UNRWA's statistics till February 2015.*

- *At least 36,000 Palestinian Syrian refugees have reached Europe during the last 4 years.*
- *The number of Palestinian detainees who were documented by the AGPS has reached 896 detainees, and 398 victims were killed due to torture in the Syrian prisons.*
- *The Yarmouk Camp: - Siege, imposed by the Regular Army and PFGC, continued for 723 days respectively. In addition, power cuts continued for more than 793 days, water was cut for 283 days respectively. The number of victims due to the siege has reached to 176 victims.*
- *Al Husayneyya Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 604 days respectively.*
- *Al Sbeina Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 585 days respectively.*
- *Handarat Camp: - Residents have left the camp for 787 days after the Syrian Opposition Groups controlled it.*
- *Dara'a Camp: - It is now almost 430 days without water and 70% of its buildings were demolished.*
- *Jermana, AL Saieda ZAINAB, Al Raml, Al Aedein Camps in Homs and Hamma: - A relatively quiet situation in light of the economic crises.*
- *Khan Al Sheih Camp: - Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.*
