The Yarmouk Refugee Camp

A long meeting was held, yesterday, in Yarmouk refugee camp, attended by each of the President of the Palestine Branch of Syrian intelligence, as a representative of the Syrian state, and a number of representatives of the Palestinian factions, in addition to representatives of civil and relief organizations and armed brigades inside the camp.



The agreement to neutralize Yarmouk refugee camp



The parties met in the Yarmouk municipality building, and after long talks and discussions, attendance signed a new agreement to neutralize the camp.

The agreement provides to put points, centering around the legal borders of the camp to ensure that no entry of any armed from outside the camp, and the formation of a military commission and a security force to maintain security inside the camp.

The agreement also provides to prevent the entry of any person currently accused of murder to the camp until the completion of civil reconciliation. The agreement pointed out that any armed who wants to return to the camp will enter as a civilian, moreover the agreement stressed to Ensure that the camp will not face any military action. In addition to open the main entrances of the Yarmouk and Palestine camps and to prepare the infrastructure, and also to commence to prevent any armed, from the vicinity of the camp and from all regions, of access to the camp permanently.

The agreement noted that the only guarantor of each of the foregoing is the state, represented only by Brigadier General Staff Chief of the Palestine branch and all security matters.

It also discusses settling the situation of detainees and an immediate cease-fire, pointing out that, at the same time all the problems of the camp like the return of the people and everything related to basic services will be solved. As a state of optimism and joy prevailed among the people after signing the agreement.

Recent Updates

Explosive barrels targeted Khan Al Sheih area adjacent to Khan Al Sheih refugee camp in Damascus city, causing large destruction of some houses, in addition to eleven victims of Safadi Syrian family; they were killed due to the destruction of their home because of the explosion. The explosions caused a state of tension and anxiety among the people inside the camp, especially that dozens of Palestinian families living in that region. The camp and its surroundings are witnessing a rise at bombardment and clashes pace over the past few months.

Meanwhile, Khan Dannoun camp in Damascus city suffers from scarcity of water, where people forced to buy drinking water from the tanks, and the camp receives hundreds of Palestinian families displaced from the camps because of the bombardment and siege. While, south of Syria, the rest of the residents of Dara'a Camp, suffer of acute crises in basic services due to the destruction of the camp after repeated shelling that targeted it, which led to extensive damage to the infrastructure of the camp.

Most of the families of Dara'a camp, which are nearly 4,000 families, most of them forced to flee the camp because of the poor conditions, as about only one hundred family remain inside the camp and suffers from difficult living conditions where basic services are almost non-existent, especially with regard to health services, electricity and drinking water.
