## Latest Developments:

AGPS's correspondent has confirmed that ISIS prevented residents of south Damascus from reaching Al-Qadam neighborhood, which became part of the agreement with the Syrian regime to allow those who desire to leave to the towns of Idlib and "Jarabulus" in north Syria, from the residents and opposition fighters.



Our reporter added that ISIS placed a checkpoint in "Al-Maaziniyah" neighborhood located in Al-Qadam, after a number of its members escaped with the neighborhood's fighters, as well as the increased movement of people from south Damascus, to accompany those leaving to the north.

There have been sharp divisions in ISIS's ranks over understandings and agreements with the Syrian government. Members of ISIS refused to sign with the regime to become popular committees, while others rejected to leave in the directions controlled by ISIS in the north of Syria.

In another context, Palestinian “Nedaa Qassem” from Aleppo died in Västerås city Hospital in Sweden, due to medical negligence and carelessness by the hospital, according to the description of the victim's relatives.



“Nedaa’s” family said that the 30-year-old attempted to meet her doctor several times, in order to treat her pregnancy that was formed outside her uterus. The severity of her case requires immediate medical intervention to save the mother from death, removing of the uterus, or never being able to give birth again.

After a long period of time and a delay in her treatment, she underwent surgery at the Västerås city Hospital and was given an anesthetic drug to lift the child out of her womb, which caused a stroke that led to her death.

This caused anger and despair towards the hospital’s treatment to the patient and the amount of carelessness in deciding to remove the child from her uterus. This isn’t the first case that has proven the bad medical conditions and negligence in Sweden.

The young Palestinian woman “Nedaa Qassem” originally from “Tarshiha” village in Palestine, was resident of Aleppo city. She graduated from Pharmacy school and worked in a pharmacy in the city. She was a mother to two girls.

In a different context, Turkish press sources said that fishing boat carrying illegal immigrants sank in the Black Sea, north-west of Turkey, while attempting to reach the European transit states. 20 immigrants died.

The Turkish Coast Guard Command said in a statement the day before yesterday that its crew had rescued 40 immigrants and is still under search for 7 to 9 people in the area.



The Anadolu Agency stated that the guards set up a civilians’ hospital in “Kefken” Port, to supervise and treat the immigrants’ health conditions, as well as specializing a plane and two helicopters to help in the search and rescue operations and transport the injured to the state hospital in Kocaeli.

## **Local Work Committees:**

Jafra Foundation for Relief and Development held a closing event for its summer activities program titled “Zahr Al-Loz” in the town of Yilda, near Yarmouk camp.

The event included many artistic and cultural segments presented by the children who attended the summer program.

Hundreds of Palestinians fled Yarmouk camp after ISIS took control of it in April 2015.

## **Palestinians of Syria: September 23, 2017 Statistics:**

- The total number of victims documented by the Action Group is 3587, including 462 women
- 1637 Palestinians are locked up behind Syrian government’s bars, 103 of which are women
- Yarmouk refugee camp is under the Syrian regime army and Popular Front for the Liberation of Palestine’s siege for 1,529 days in a row
- 199 refugees, mainly in Yarmouk Camp, have died due to lack of medical care and malnutrition
- Water supplies have been cut off Deraa Camp for 1266 days, and 1106 days in Yarmouk Camp
- Residents of Handarat Camp, in Aleppo have been banned from their homes for 1,602 days. Government troops have taken over the camp for more than 353 days.

- Approximately 85 thousand Palestinian-Syrian refugees fled to Europe by the end of 2016
- 31 thousand refugees are located in Lebanon
- 17 thousand refugees are sheltered in Jordan
- 6 thousand refugees are in Egypt
- 8 thousand refugees are staying in Turkey
- One thousand refugees are present in Gaza
