Latest Developments

51 Palestinians from Syria, among them women, children, and elderly refugees, drowned onboard the death boats to Europe, fleeing the war-tattered Syrian territories.

A number of casualties breathed their last off the Libyan seashores, trying to disembark in Italy while others sunk in Marmara waters as they tried to reach the Greek coast.



Hundreds of Palestinian migrants have risked their lives onboard the “death boats” sailing from such launch-off destinations as Turkey, Libya, and Egypt, fleeing the deadly warfare in Syria.

At the same time, 82 Palestinians taking refuge in AlSabina Camp, in Rif Dimashq, died of war-related incidents in Syria.

The list includes 40 Palestinians who were killed under shelling, 18 who were fatally gunned down, and six refugees who were shot with snipers’ bullet fire.

Nine refugees from AlSabina were, meanwhile, tortured to death in Syrian government jails; one refugee was executed; three Palestinians died as a result of the blockade and medical negligence;

two others died in car blasts, and another was killed with a white weapon. Two more refugees died of unidentified causes.

AGPS kept record of the death of 3,894 Palestinians from Syria since the launch of the deadly warfare.

In the meantime, Association 302 to Defend Refugees' Rights has called for urgent action by UNRWA as regards 1,500 Palestinian refugees taking shelter in Deir Ballout Camp after they were displaced from Yarmouk Camp and southern Damascus some six months ago.



Association 302 said in a Wednesday statement that the humanitarian situation in Deir Ballout Camp, north of Syria, has been incredibly disastrous, calling for urgent humanitarian action by UNRWA.

The commission warned of the swift propagation of snakes, which it said puts the lives of children at risk.

It added that helpless refugees have been sheltered in non-equipped tents that risk to be swamped by rain floods.

The commission also said that the refugees have been left without clinics, schools, and kindergartens. Dozens have found no other option than to walk for hours to reach a hospital or a clinic so as to treat an ill child, fetch medicines for an ailing elderly woman, or help a pregnant lady deliver her newborn.

Commission 302 said the rallies staged by the refugees for the third week running come at a time when humanitarian conditions have gone remarkably downhill in the area. Civilians have been shorn of food, clothing, and psycho-physical assistance.

In another development, Palestinian refugee Mouloud Khaled AlAbdullah has been held in Syrian government jails for the fifth year running after he was kidnapped with his family on July 27, 2013 from Nisreen Street, near Yarmouk Camp.

Aged 73 at the time of his abduction, Mouloud was diagnosed with critical cardiovascular disorders. His condition and whereabouts have been shrouded in mystery.
