*"AGPS: At Least 195 PRS Children Were Killed Since the Beginning of the War"*



- Two Palestinian Syrian refugees killed in Syria.
- Appeals to prevent the Lebanese authorities from deporting a Palestinian refugee towards Syria.
- Family of the Palestinian abductee "Mohammad Mawid" appeals again to uncover their son's fate.
- Palestinian Syrian refugees families displaced to Qudsayya suffer from hard living circumstances.

## **VICTIMS**

*Palestinian refugee "Sabri Jihad Al-Saabi" was killed on Saturday due to the regime's heavy shelling on the city of Darya in western Gota of Damascus, noting that he is the fifth victims of the same family where "Ahmed Salim Al-Saabi" and "Hossam Salim Al-Saabi" and "Salim SabriAl-Saabi" and "Mohammed Sabri Al-Saabi" were killed previously.*

*The Palestinian refugee "Hamid Tallaa" from Daraa camp south of Syria, shot dead by a sniper, bringing the number of Palestinian refugees' victims from Daraa camp since the beginning of the war to (231) victim.*



## **RECENT UPDATES**

*AGPS' Monitoring and documentation team confirmed documenting (195) Palestinian children have been killed since the beginning of the conflict in Syria. Including 105 children were killed by the bombing, (14) by a sniper, (7) by gunshots, (1) under torture, (21) drowned, while (1) for unknown reasons, (17) as a result of car bombings, (24) as a result of the blockade and the lack of medical care, (1) burned to death, (1) by suffocation, (1) crushed to death, and (1) kidnapped and then killed.*



*The team said, the real number is most likely to be more than that due to the inability to confirm the ages of all the victims as the war conditions often hinder this.*

*In another context, family of the Palestinian refugee "Ahmed Hussein Khalid" appealed to the international and human rights organizations as well as to the Palestinian Embassy in Lebanon, to intervene to prevent his deportation to Syria. The Lebanese authorities started deporting him after he was forcibly returned from Sudan to Lebanon. His family and Palestinian activists warned that this deportation to Syria poses a major threats to his life, knowing that he was on his way to the Al-Masnaa Border Point, accompanied by Lebanese security.*

*It is noteworthy that this is not the first time the Lebanese authorities deport Palestinian refugees to Syria, the last of which was in the 09 November 2015, when the Lebanese authorities deported two PRS brothers "Tariq Nidal al-Khatib," and "Izzo Nidal Khatib" to Syria, after their arrival at Rafik Al-Hariri Airport in Beirut coming from Turkey.*

*Turning to the south of Damascus, where the family of the activist "Mohammed Mawid" renewed its appeal to all parties in the Yarmouk refugee camp, to contribute to reveal the fate of their son.*





*Mawid, an activist and one of the Palestinian Red Crescent volunteers, have been kidnapped in the Yarmouk refugee camp since 1 February 2016, where his fate is still unknown, as well as the kidnappers and the reasons behind that incident.*

*In the meantime, suffering of around 6000 Palestinian families displaced from the Yarmouk refugee camp and other camps to Qudsaya Town in Damascus Countryside is still going on as a result of the blockade imposed by the regime's army since 21 July 2015, which reflected negatively on health and living sectors.*

*Civilians there also complain of high unemployment of up to 96%, and the lack of heating materials, and severe loss of medicines.*

### ***Palestinians of Syria in numbers and statistics Until 28 February 2016***

- *15,500 Palestinian Syrian refugees in Jordan, 42,500 Palestinian Syrian refugees in Lebanon, and 6,000 refugees in Egypt, according to the UNRWA's statistics till July 2015.*
- *More than 71,200 Palestinian Syrian refugees have arrived Europe until the end of December 2015.*
- *The Yarmouk Camp: still under siege imposed by the Syrian Regime's Army and PFLP-GC (Popular Front for the Liberation of Palestine – General Command), continued for 988 days respectively. In addition, power cuts continued for more than 1050 days, water cut for 538 days. The number of victims due to the siege has reached to 186 victims.*

- *Al Sbeina Camp: Syrian Regime's Army still preventing the residents from returning back to their houses for 844 days respectively.*
- *Handarat Camp: All of its residents have left the camp for 1037 days after the Syrian Opposition Groups controlled it.*
- *Dara'a Camp: Running water cut continues for 698 days, and 70% of its buildings were destroyed.*
- *Jarmana, AL-SaiedaZainab, Al-Raml, Al-Aedein Homs and AedeinHama: A relatively quiet situation in light of the economic crises.*
- *Khan Al Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia-Khan EShieh road.*
