### *"The Families of the Torture Victims Condemn the Palestinian Factions' Silence towards the Suffering of their Relatives"*

### **Victims**

*7 Palestinians died due to torture in the prisons of the Syrian regime; they are:*

- *The young man "Hani Jamaan," 25 years from the Yarmouk camp died after being arrested since January 2014, while the Syrian security forces handled his ID to his family.*
- *The refugee woman "Shahd Abu Yasein," 28 years from Damascus city died after being arrested since the beginning of 2012 in charges of the relief activity. She is a mother of a girl and the Syrian security handled her ID to her family.*
- *The two refugees "HareisMuhsenRmeid," 55 years and his son "Mohammed HareisRmeid," 20 years died after being arrested for several months, while the Syrian security handled their IDs to their family. It is mentioned that they are from Husseneia camp in Damascus suburb.*
- *The refugee woman "Farah Ahmed Abdulsalam," 19 years from Damascus suburb died after being arrested by Al Qatifa checkpoint members on 15-4-2013.*
- *The refugee woman "HAdeil Al Khatieb," 25 years from Al Lathakeia died due to torture after being arrested since 30-11-2011.*
- *The refugee woman "Amna Al Hawwari," 36 years died due to torture in the prisons of the Syrian regime after being arrested since the mid of 2012 by the members of the regime checkpoint at Daraa road-Damascus in charges of her broken ID.*

*It is mentioned that 364 Palestinian victims died due to torture in the Syrian prisons till yesterday and were documented by the AGPS according to the group statistics.*



### **Recent Updates**

*A number of relatives of the victims of torture in the Syrian regime's prisons issued a statement denouncing the silence of the Palestinian factions toward the suffering of their relatives in the cellars of the arrest. According to a statement received by the AGPS, the families deplored the silence of all the Palestinian factions and the Palestinian Authority represented by its ambassador in Damascus, "Anwar Abdul Hadi" and their ignorance of the torture massacre of their children in the cellars of the Syrian regime. "*

*The statement considered that "everyone ignored the massacre is only a partner, and the blood of their sons who died under torture in the necks of the silent and defeatists who did not denounce or condemn or permit."*

*It also pointed out "that the families did not find any words or actions by the Palestinian factions to find a way to protect the detainees from death under torture in the Syrian prisons, or to contribute to the release of those who remain in the prisons to relief their families.*

*Adding that "people do not know the fate of their children and whether they were alive or died due to torture similarly as to the others who were announced or their painful photographs were leaked.*

*In a related context, the people the Yarmouk camp in Damascus performed the funeral prayer on the lives of hundreds of Palestinian refugees who have died under torture in the prisons of the Syrian regime.*



**Water crises in Yarmouk camp**





*Amid accusations by the Relatives of the victims to the Palestinian factions of being disappointing, where a victim's sister considered that the Palestinian factions involved the murder of her sister because of the silence throughout the period in which her sister was arrested, which exceeded two years.*

*This comes in light of the continued siege on the camp for (630) days, respectively, and the continuation of the water cut for (200) days.*

*In Damascus suburb, the surrounding farms of Khan Al Shieh camp for Palestinian refugees in Damascus suburb exposed to violent shelling rocked the camp, which led to the spread of panic among the residents for fear of being bombed as well.*

*It is noteworthy that all the roads connecting between the camp and the center of the capital Damascus are closed except for Zakia - Khan Al Shieh which reflected negatively on the presence and the prices of basic materials inside the camp.*

### **Civil Work Committees**

*Jafra foundation for Relief and Development distributed an amount of food and medical aid to the residents of Khan Al Shieh camp in Damascus suburb in an attempt to alleviate the suffering of the residents who are mostly lost their jobs due to the security situation, while the others left the camp due to the shelling.*





*Meanwhile, The Charity Committee for the Relief of Palestinian People resumed distributing bread to the besieged families in the Yarmouk camp. The committee announced that it distributed about 1700 bread packs during the past three days.*

### ***Numbers and Statistics till 28/3/2015***

- *At least 27933 Palestinian Syrian refugees have reached Europe during the last 4 years.*
- *Torture Victims in the Syrian Prisons are 357 Victims, and 819 Detainees.*
- *The Yarmouk Camp: - Siege, imposed by the Regular Army and PFGC, continued for 630 days respectively. In addition, power cuts continued for more than 710 days, water was cut for 200 days respectively. The number of victims due to the siege has reached to 172 victims.*
- *80,000 Palestinian Syrian refugees escaped from Syria to the neighboring towns, including 10,687 refugees in Jordan, 51,300 in Lebanon and 6,000 refugees in Egypt, according to UNRWA statistics till February 2015.*
- *Al Husayneyya Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 531days respectively.*
- *Al Sbeina Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 501 days respectively.*
- *Handarat Camp: - Residents have left the camp for 703 days after the Syrian Opposition Groups controlled it.*
- *Dara'a Camp: - It is now almost 347 days without water and 70% of its buildings were demolished.*
- *Jermana, AL SaiedaZainab, Al Raml, Al Aedein Camps in Homs and Hamma: - A relatively quiet situation in light of the economic crises.*
- *Khan Al Sheih Camp: - Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.*
