### *"Residents of Husseneia Camp Complain of the Security Members Domination"*

### ***Recent Updates***

*A mortar shell targeted Al- Redah Street in Khan Al- Shieh camp for Palestinian refugees in Damascus Suburb which led to material damage, coincided with sporadic shelling that targeted the surrounding farms and towns.*

*Meanwhile, all roads that connect the camp and the surrounding areas are still closed except (Zakia – Khan Al- Shieh) road, while communications, especially mobile phone, are cut due to the theft of telecommunication generators and cables.*



*In another context, the so-called "Sharia Court" of the Syrian armed opposition in the western Ghouta issued a decision that obligates "Al- Fateheen Brigade" group, one of the armed opposition groups, to pay the religious expiation for killing the young man "Thabet Faour," a resident of Khan Al- Shieh camp, after confirming he was innocent from cooperation with the Syrian regime according to the court decision.*

*In addition, "Al- Fateheen Brigade" group abducted "Thabet Faour" and executed him on charges of cooperation with the Syrian regime,*



*provoking his family to complain to the legitimacy court which proved his innocence after verification and witnesses call and ordered the group to pay money as a religious expiation for killing him unjustly.*

*It is noteworthy that the action group had documented numerous abuses committed by opposition armed groups against the residents of Khan Al-Shieh camp, as Al-Nusra Front executed three Palestinian refugees on April 18, 2015, after arresting them for more than 7 months. The detainees are: "Abdullah Saeed Khnefes," "Abdul Rahman Saeed Khnefes" and "Nabil Awad Fares."*

*On September 7, 2014, a group of the opposition opened fire on the residents of the camp which led to two victims; they are: "Mohammed Methqal Al- Qadih" and "Mohammed Saleh Saleh," as a number of civilians were wounded, including "Essam Hussein" and "Ali Hamadeh."*

*On July 16, the Syrian opposition groups stormed the camp under heavy shooting at Al Makhfar and Al Madares area causing a state of panic among residents.*

*Moreover, these groups arrested a number of residents, as they were taken to an unknown destination.*

*On July 16, "Wael Abu Zahrah," a resident of Khan Al- Shieh camp, died after being abducted by a group of the Syrian opposition, while "Mohammed Khnefs" and "Abu Irfan Khnefes" were released.*

*However, on August 3, 2014 these groups stormed the camp and inspected the home of "Mohammed Jarwan Saleh" searching for "Mo'een Jarwan," while they killed "Mohammed Jarwan."*



*In addition, the group raided the home of "Ahmed Al- Ramli," a teacher at an UNRWA school and arrested him.*



#### ***Hussainia camp***

*In Damascus suburb, residents of Hussainia camp complained via social network to the involved parties demanding the Syrian state to intervene with the Syrian security detachment in their camp after a decisions issued by the detachment and its security official in the region, including:*

- Any family proved to have an armed member is expelled from the area and its property is confiscated by the checkpoint.*
- In case a provider of a family is not present is expelled and its property is confiscated*
- The rented shops are not allowed to be re-opened.*
- Shops owners are allowed to open their store provided that they buy their products from traders assigned by the head of checkpoints in the area in order to control prices and prevent the entry of goods from outside the region.*



*After filing a complaint to the Commission of Reconciliation in the region, the response was that there is nothing to do regarding the issue.*

*It is noteworthy that residents of Husseinia camp returned after about three years and after great efforts made by them and the Reconciliation Commission to the Syrian authorities to intervene with the Syrian army and security in order to open the way for their return to their homes.*

*Al- Saida Zainab camp, which is controlled by the Syrian army and the Popular Commissions, is considered one of the most relatively clam Palestinian camps, yet its residents are suffering from an economic crisis that increased the burdensome costs on the Palestinian family, in light of the weakness of potentials and financial resources, as well as the spread of unemployment, prompting some residents to travel or work with the pro-regime Popular Committees.*



#### *Al- Saida Zainab camp*

*In the beginning of 2013, the armed opposition groups entered the camp, and after violent clashes and shelling for 7 months, the Syrian army entered the camp and then the Palestinian popular committees loyal to the Syrian army took over the task of protecting the camp.*



*Those battles affected negatively on the camp and its residents; a large part of the camp was destroyed, while many of its residents were killed; estimated by some reports to 100 victims and 200 injured between amputation and permanent disabilities.*

*The AGPS documented the names of 42 victims.*

*In the north of Syria, the Palestinian refugees, who were displaced from Handarat camp for 781 days consequently, are still suffering, as they were displaced from their homes after the Syrian armed opposition controlled the camp.*

*In addition, residents of the camp are facing difficult living condition due to displacement and continuing war in Syria and its repercussions on the economic situation, which led to the weakness of financial resources and spread of unemployment.*

*Handarat camp and adjacent areas are still witnessing bombing and violent clashes between the Syrian armed opposition groups and the regular army alongside a group of al-Quds Brigade, while the regular army is trying to impose its control over the camp which stands as a strategic area, and the opposition groups are seeking to advance towards the town of Handarat Aleppo central prison.*

*The AGPS monitoring and documentation team documented the names of 59 victims from Handarat camp, as well as it documented the names of 32 detainees from the camp in the Syrian prisons.*



### **Lebanon**

*The Relief and Development Organizations League in Lebanon declared a campaign for kidney dialysis patients for one year to the Palestinians of Syria and the Palestinians in Lebanon.*



*The Palestinians of Syria Committee in Lebanon clarified that patients can contact the league through phone and sent their names, age, phone, address, and treatment sessions they need during one week.*

*It is mentioned that many of patients from the Palestinians of Syria refugees complain from the inability to pay the treatment costs after they were treated for free in the Syrian hospitals.*

*It is referred that the number of Palestinians of Syria refugees in Lebanon, who escaped the ongoing conflict in Syria, is 45000 refugees.*

*In a different context, the Students Committee at the Palestinians of Syria Committee in Lebanon, and under the patronage of the famous TV program titled "Let us Head to Al Aqsa" which is presented on internal TV channels in the Lebanese camps in the north in order to shed the light*



*on Al Aqsa Mosque and the systematic storming and invasions which aim at dividing the mosque by place and time.*

*The TV program, which was broadcasted yesterday on Al Renawi and Al Sharq channels, included children series, a competition about Jerusalem and Al Aqsa Mosque and its geographical location, historical importance, and its religious importance to the Muslim and Arab people.*

*30 children won the competition and were awarded with valued prizes. At the end of the series, a cartoon movie was displayed about Al Aqsa Mosque and violations.*

*It is worthy to mention that the Palestinians of Syria Committee in Lebanon is serving the Palestinians of Syria refugees in Lebanon and aims at shedding the light on the suffering and pain of the refugees and to help them.*

### ***Numbers and Statistics till 29/9/2015***

- *15,500 Palestinian Syrian refugees in Jordan, 45,000 Palestinian Syrian refugees in Lebanon, and 6,000 refugees in Egypt, according to the UNRWA's statistics till July 2015.*
- *At least 36,000 Palestinian Syrian refugees have reached Europe during the last 4 years.*
- *The Yarmouk Camp: - Siege, imposed by the Regular Army and PFGC, continued for 819 days respectively. In addition, power cuts continued for more than 889 days, water was cut for 379 days*

*respectively. The number of victims due to the siege has reached to 182 victims.*

- *Al Sbeina Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 681 days respectively.*
- *Handarat Camp: - Residents have left the camp for 882 days after the Syrian Opposition Groups controlled it.*
- *Dara'a Camp: - It is now almost 527 days without water and 70% of its buildings were demolished.*
- *Jarmana, AL Saieda Zainab, Al Raml, Al Aedein Camps in Homs and Hamma: - A relatively quiet situation in light of the economic crises.*
- *Khan Al Sheih Camp: - Roads linking the camp to the city center are still closed except for Zakia- Khan Al Shieh road.*
