### ***“Groups of Syrian Opposition Broke into Khan Al Sheih Camp and assassinated one of its Residents”***

### **Victims**

*Mohammed Jarwan Saleh from Khan AL Sheih camp was killed by groups of the Syrian opposition.*

### **Recent Updates**

*A state of anger and discontent prevailed in Khan AL Sheih camp because a group of Syrian opposition that has broke into the camp and made inspection and search campaign and assassinated one of the residents and arrested a number of them.*

*In details, our correspondent said that armed groups of the Syrian opposition broke into Khan Al Sheih camp in the morning and made raid and search campaign on the house of Mohammed Jarwan who is wanted for them.*

*This group has killed Mohammed Jarwan and raided the house of Ahmed Al Ramly, a teacher in UNRWA school, and arrested him; therefore, a number of activists and notables demanded the groups of Free Army to punish this armed group and bring them to trial and not to involve the camp on the ongoing conflict in Syria.*

*The activists and nobles confirmed that the camp contains unarmed civilians who do not hold any kind of weapons, so they call all concerns parties to neutralize the camp. It is worth mentioning that the Syrian opposition groups have made many violations, recently, to the residents of Khan AL Sheih camp.*

*On 9-7-2014, they opened fire on the residents of the camp which led to the death of two civilians, Mohammed Methqal Al Qadeia and Mohammed Saleh Saleh and the injury of Issam Hussein and Ali Hamada.*

*On 16-7-2014, groups of Syrian opposition broke into the camp under a heavy fire in Al Makhfar and Al Madares Street, which caused a state of*



*fear among the residents, while they arrested a number of civilians and led them to unknown destination.*

*Wael Abu Zahra from Khan Al Sheih camp was killed in 20-7-2013, after being kidnapped by a group affiliated to the Syrian opposition, meanwhile, Mohammed Khnaifes and another one from Abu Irfan family were released.*

*Jaramana camp is located 8 kilometers of Damascus on the way of Damascus International Airport was bombed by a number of artillery shells targeted separate places of the camp resulted in a number of injuries.*

*The residents of Jaramana camp suffer of shortage in food supplies, medicine and fuel, while the camp is receiving thousands of families who were displaced from Palestinian compounds and adjacent areas because the deterioration of security situation.*

*About 30 families returned back to the Yarmouk camp, they were allowed by the Syrian security after making a list of 146 names that are approved to enter.*



*The entry of 30 families comes under the implementation of the initiative items of breaking the Yarmouk siege, which all parties inside the camp have committed to it.*

*In terms of field situation, the implementation of the initiative items of breaking the Yarmouk siege, which was signed two days ago, is still ambiguous.*

*In terms of medical conditions, PRCS continues the vaccine campaign for children at Dier Yasien compound near Palestine hospital, while medical sources said that typhoid disease began to decrease after the vaccine campaign.*

*Meanwhile, the people of Yarmouk camp are still suffering of the lack of food supplies as a result of the siege imposed on the camp and that what forces them to use primitive methods to compensate the food shortage.*

*Relief institutions in cooperate with the people of Yarmouk camp have cultivate the empty lands, public parks and houses roofs with various kinds of summer vegetables, which alleviate the suffering and pain resulted in the siege.*



*According to a woman testimony, “we have come to eat from the bounties of these lands and this positive step eased the hunger that we suffer, but it was a must to take step a long time ago.”*

*The Regular Army and the members of PFLP-General Command have imposed partial siege on the Yarmouk camp on 18-12-2013 and imposed a complete siege on 18-7-2014.*



#### ***The vaccine campaign for children***

*On the other hand, a number of shells hit Al Wafedien camp, which contains a number of Palestinian refugees and displaced Syrians, and different parts of the camp were bombed without any casualties, which led to a state of tension amongst the people who are suffering of poverty, unemployment and poor living conditions even before the outbreak of the events in Syria.*

*Al Wafedein camp is located in the northern entrance of Damascus city on the road of the highway between Damascus and Homs, away from the capital Damascus, 20 kilometer.*

*The camp is bounded on the north by the highway, on the south-east Adra Prison, on the south city of Douma, on the west Al Iskan suburb.*

*It consists organizationally of three neighborhoods, the first is Al Golan, the second is Teshrien and the third is Al Thawra neighborhood.*



*The camp is administratively followed to the province of Quneitra, which was officially named (Batiha for displaced people), a population of about 53 thousand people, and the majority of its population displaced from the occupied Golan.*
